

## Annual Meeting FAQs

### **Will the AADSM Annual Meeting be rescheduled to take place later this year?**

No. We had a top-notch program planned for this year's meeting, and we will be working to find other avenues to disseminate the content planned for the meeting to members in a timely manner and will keep you informed. ### **Will my registration be refunded?**

Due to these unprecedented circumstances, the AADSM is making an exception to its cancellation policy. Registrants have two options regarding their registration fee: transfer it to the 2021 AADSM Annual Meeting, which will be held April 30-May 2 in Chicago, Illinois or request a full refund. Refunds will be processed within 90 days of receipt of request via electronic payment, check or international wire transfer. Should you choose to have your registration refunded, you can avoid mail delays by receiving an electronic payment refund. For this refund method, you will be asked to provide the following information: bank name, routing number, account number and name of account holder.

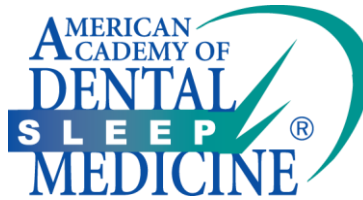
All registered attendees must complete [THIS FORM](#) by **Wednesday, April 15** to notify the AADSM if they want to transfer their registration or receive a refund.

### **Will the AADSM refund any hotel costs?**

No. Registrants must contact the Hilton New Orleans at 504-584-3999 directly to cancel reservations and are responsible for any associated fees from hotels. Hotel reservations must be cancelled 72 hours in advance of when you were scheduled to arrive. Please note that the AADSM has sent official meeting cancellation correspondence to the hotel.

### **Will the AADSM refund for airline tickets?**

No. The AADSM will not refund individual airline ticket costs. Please contact your airline directly regarding ticket cancellations. If you purchased travel insurance, please contact your provider for information and next steps.



**Will abstracts submitted for the meeting be available?**

Yes, abstracts submitted for the meeting will be published in the April issue of the *Journal of Dental Sleep Medicine*. Late-breaking abstracts will be published in the July issue of the *Journal of Dental Sleep Medicine*.

**Will exhibitors be refunded for booth space and meeting sponsorships?**

Due to these unprecedented circumstances, the AADSM is making an exception to its cancellation policy. Exhibitors can apply their paid booth fees and meeting sponsorships to the 2021 meeting or receive a full refund. Any increases in exhibit or sponsorship fees will be waived for companies that apply their booth and sponsorship fees to the 2021 meeting. Companies must complete [THIS FORM](#) by **Wednesday, April 15** to notify the AADSM if they want to transfer their booth and meeting sponsorship fees to the 2021 AADSM Annual Meeting or request a full refund.
